I rent from you the cart described on the other side of this agreement and I agree to the terms below and on the other side. I and me refer to the person who signs this agreement. You and your refer to Claridge Golf Cars.

WHEN I'LL RELINQUISH THE CART

I'll relinquish the cart on the date indicated on the front. I'll relinquish it sooner on your demand.

WHERE I'LL RETURN THE CART

I'll return the cart to Claridge Golf Cars office in Madeira Park on the day indicated on the front or sooner, unless arrangements are made for pick-up by Claridge Golf Cars at an additional charge.

RENTAL CHARGES.

I will pay for the length of time I rent the cart in advance. The minimum charge is one day (24 hrs.). I will pay any charges for miscellaneous services which apply to the rental. I realize a surcharge will apply to any rental paid by credit card.

FINES AND EXPENSES

I'll pay all fines, court-costs and other expenses for parking, traffic and other violations with respect to the use of the cart while on rental to me unless due to your fault.

USE OF THE CART

I will not allow any use of the cart to carry passengers or property for hire or to tow or push anything. I won't allow it for any illegal purpose or by any prohibited driver (i.e. anyone under 17 years of age or anyone without a license over 17 years of age).

WHO ELSE MAY DRIVE THE CART

Only those listed at the time the contract is signed may drive the vehicle provided they hold a valid driver's license and are over 17 years of age. I understand I am responsible to pay any damage or injury caused by any driver listed as an additional driver or whomever is driving the cart if the person is not listed.

DAMAGE TO THE CART

I understand the insurance on the cart is third party only. I understand any damage to the cart, passengers or third parties not covered by insurance will be my responsibility. Should the cart be damaged beyond repair, I'll pay you for all the damage up to the maximum prevailing retail value of the cart before it was damaged. In the event the cart is not damaged beyond repair, I'll pay you for all the damage up to the maximum prevailing retail price for the parts and labor whether or not Claridge Golf Cars costs for repair are less. I'll be responsible for these charges which together constitute the loss regardless who is at fault. I will be responsible for the loss if I or any additional driver or anyone not listed: 1) abuse the cart; 2) drive it recklessly or while under the influence of alcohol, drugs or chemical substances; 3) fail to promptly report any damage to the cart to Claridge Golf Cars and/or police; 4) obtain the cart through fraud or misrepresentation and damage the cart; 5) operate the cart off roads or on the beach; 6) steal the cart and/or vandalize the cart. I will also be responsible for any loss of rental time while cart is being repaired.

REPOSSESSING THE CART

You can repossess the cart at anytime if it is found to be illegally parked, being used to violate the law or this agreement or appears abandoned. You can also repossess anytime you discover that I made a misrepresentation to obtain the cart. You needn't notify me in advance. If the cart is repossessed, any deposit will be forfeited at the discretion of Claridge Golf Cars. (i.e. if anyone under 17 years of age is found driving the cart.)

COLLECTIONS

All charges, fees and expenses including payment for the loss or damage to the cart are due at your request. If I do not pay all the charges when due, I agree to pay a late charge of 1½% per month or on the past due balance I will pay any collection costs including your reasonable attorney's fees if I don't pay any amount when due, if the law permits you may contact me or my employer at my place of business in connection with your collections.
